The Rossmoor Emergency Preparedness Organization Dedicates this Meeting to Arlyss Rothman – Past Vice President of the EPO



Arlyss Rothman, former Third Mutual president, dies

Arlyss Rothman, who was a former Third Mutual board member and president and current vice president of the Rossmoor Emergency Preparedness Organization (EPO), died Oct. 19 following a long fight with cancer.

Rothman, 74, made her mark in Rossmoor almost immediately after she and husband, Al, arrived in 2015. She started as an entry coordinator for Third Mutual and was later Project 45 coordinator before being appointed in 2017 to fill a vacancy on the Third Mutual Board of Directors. She was subsequently elected to a full board term and was the board president when her term ended in June.

"She thought of everybody here as her family, the people of Rossmoor," said Al Rothman, a retired family doctor and Arlyss' husband for almost 47 years. "For her, public service was a way of showing she loved them."

That service also included volunteer work as a vice president for three years with the Rossmoor EPO, and with Rossmoor Area Community.
